#### **GENERAL PROVISIONS:**

1. The administrator of your personal data is the service provider, named Exact Systems

- 2. We protect your personal data in accordance with the requirements of Polish law, in particular in accordance with regulation (EU) 2016/697 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regards to the processing of data on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 165, 30.4.2004, p. 11). 119, p. 1).
- 3. Personal data made available through the e-learning platform will be processed and used by the service provider indicated in § 1 paragraph. 1 above for the realization of recruitment processes conducted by the service provider, including an increase in the possibility of finding an offer corresponding to your expectations.

### § 2 DEFINITIONS:

The definitions used in this e-learning platform are as follows:

1. Service provider – an e-learning platform operator and having access to electronic tools to manage user accounts that is:

- 4. Recruitment process on-line recruitment carried out by the service provider via the e-learning platform, consisting of five successive stages, from which the transition to each subsequent step is conditioned by the correct completion of the previous stage: (1) Registration and establishment of an e-learning platform account, (2) taking part in recruitment tests, (3) receiving full access to the e-learning platform, (4) Completing the adaptation training, (5) supplementing the personal data necessary for the conclusion of Agreement.

- 1. Your personal data will be processed for the purposes of:

Labour Code (OJ L 2018, item 108, as amended), hereinafter referred to as the "Labour Code", in the ZW of article 6 (1) (c) of Regulation (EU) 2016/697 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 165, 30.4.2004, p. 11). EU no 119, p. 1), hereinafter referred to as "the RODO regulation", article 6 (1) 1 point. c) of the RODO regulation] in fulfilling the legal obligation to the service provider. The provision of personal data is voluntary but necessary to participate in recruitment.
- B) based on your consent, taking into account your candidacy for recruitment processes and future recruitment processes, sending you information about new job offers and administration requests (legal basis: article 221 of the Labour Code In ZW. with article 3. Article 6 (1) 1 point. (a) The RODO regulation, art. Article 6 (1) 1 point. (a) RODO regulation). The provision of personal data is voluntary but necessary for the posting of personal data in the database of candidates.
- D) Protection against claims, the basis for processing is the legitimate interest of the provider [legal basis of Article 6 (1) (f) of the RODO regulation].
- 2. The period of processing of personal data shall be subject to its purpose for processing by the service provider and so appropriately for the purpose of:
- a) indicated in paragraph 1 point. a), b), c) above personal data will be kept for the duration of the recruitment process but not more than 12 months after the registration of the user or until the cancellation of consent is given;
- b) indicated in paragraph 1 point. d) above personal data will be kept for a period of time corresponding to the limitation period of the claims that the service provider may raise and which may be raised to the service provider.
- 3. You have the right to:

## § 4 INFORMATION ABOUT USE OF E-LEARNING PLATFORM:

- 1. In order to start recruitment process, it is necessary to provide the following personal data: First name, surname, telephone number, e-mail address. Then, in order to establish the user's cooperation with the service provider, it is necessary to provide the following personal data: Date of birth, social Security number, place of birth, full address, nationality, passport number, bank account number, and also other data required by law to conclude a contract with yourself, collectively referred to in this Privacy policy: "Personal Information".
